Budgeting for Women's Rights: Where is the commitment?

Gender and development in the next EU Multiannual Financial Framework (MFF)

Women's organizations play a crucial role in advancing women's human rights, yet they are marginalized when it comes to donor funding. The EU is committed to play a leading role in supporting international initiatives to promote women's and girls' rights, gender equality and the empowerment of women and girls. The adoption of a gender-responsive budget and adequate funding would be a prerequisite to match these ambitions and to ensure meaningful impact in the lives of women and girls in developing countries. But how does the reality in EU development politics look like?

In this discussion, experiences of civil society organisations, especially of women's rights organisations in developing countries, will be shared. Do they have access to EU funding? Are feminist organizations included in political dialogue processes with EU institutions? Are women's needs on the ground taken into account? Which lessons can be drawn for the implementation of the EU Gender Action Plan until 2020 and for the negotiations of the next EU Multiannual Financial Framework (MFF)? The panellists will expose their views on how EU, member states and civil society organisations can contribute to fulfil women's rights and reach the SDGs based on a gender-responsive approach and targeted action.

Eunice Musiime is a lawyer, feminist and human rights activist. She is the Executive Director of *Akina Mama wa Afrika* (AMWA), a feminist, pan African non-governmental organization with headquarters in Uganda. A flagship programme of *Akina Mama* is the *African Women's Leadership Institute* that has built the capacity of over 5.000 women in feminist and transformative leadership to effectively influence policy and practice on the African continent. Eunice Musiime holds a Bachelor's Degree in Law from the University of Dar es Salaam, Tanzania and a Masters in Business Administration from the University of Birmingham, United Kingdom.

Fabienne Van Den Eede

Fabienne Van Den Eede has been working for the European Commission for 19 years in different functions. She joined the Development Cooperation DG in 2001 where she worked on several topics and issues in the ACP countries and the Neighbourhood region. The last 8 years she has spent in Africa, in Kenya working on Kenya and Somalia as Head of Finance and Contract, and in Zambia as Head of the Governance and Social Section.
